EVENT: Tope Elementary Craft Fair

BOOTH SPACE: Booth spaces will include a table 6-8 ft in length, and 2 chairs (extra chairs available upon request). Booth spaces may vary slightly. No phone reservations will be accepted for booth space – payment must accompany a reservation form. SPACES WILL NOT BE HELD WITHOUT FULL PAYMENT.

BOOTH RENT: \$40 per space

SETUP/CLEANUP: Doors will open at 7:30 am for participants to begin setting up. All booth spaces must be cleaned up by 4:30 pm. Participants must provide their own set up including table coverings, etc. (1 table and 2 folding chairs will be provided). Some electrical outlets are available, but cannot be guaranteed.

MERCHANDISE: At this time all types of merchandise such as arts & crafts, antiques, collectibles, food vendors, import and commercial vendors, etc. will be allowed. Event organizers reserve the right to limit merchandise types allowed during the event.

- All food items must be packaged “to go” with no items being sold for consumption on school property.
- Participants are responsible for collection of sales tax.
- Participants shall park away from the front of the school after unloading to allow for customer parking during the event.
- Tope Elementary reserves the right to refuse the use of school space to any group or individual.

- If your application is declined, your payment and an explanation will be returned to you immediately.
